RECOMMENDATION

That Report FIN-11-11 dated March 28, 2011 regarding Council's Statement of Remuneration be received.

BACKGROUND

The Municipal Act, Sec. 284 requires the Treasurer to file with Council by the 31st of March, a statement of total remuneration and expenses paid in the previous year to members of Council in respect of his or her services as a member of Council or any other body, including a local board. Further, the Treasurer is required to include each person appointed by the municipality to serve as a member of any body, including local boards.

Sec. 284 (2), of the Act also specifies the statement shall identify the by-law under which the remuneration or expenses were authorized to be paid. The 2010 salaries, expenses and benefits for Mayor and Council were authorized by By-law (2006) - 18097.
